

B Y L A W S

OF

THE TORREY PINES SOARING COUNCIL

ARTICLE I

NAME OF ORGANIZATION

Section 1: The name of this organization shall be The Torrey Pines Soaring Council, and it is hereinafter for convenience sometimes referred to as the "Soaring Council".

ARTICLE II

PURPOSE

Section 1: The purpose of this Council shall be to assist and advise the Park and Recreation Department in formulating policies and coordination of activities relating to Soaring at Torrey Pines City Park.

ARTICLE III

MEMBERSHIP AND VOTING

Section 1: Membership shall consist of two representatives appointed from each of the following organizations:

1. Associated Glider Club of Southern California
2. Ultra-Light Flyers Organization
3. Torrey Pines Gulls Radio Control Soaring Society, Inc.
4. University of California at S.D. Glider Club
5. Torrey Pines Hang Gliding Association
6. National Soaring Society

Section 2: In the event a Council member is unable to attend Quarterly or Special Meetings he shall designate a representative to attend in his place as a proxy.

Section 3: Only one member of each organization or proxy shall be entitled to vote at all Quarterly or Special Meetings.

ARTICLE IV

OFFICERS

Section 1: The officers of this Council shall be a Chairperson, a Vice-Chairperson, a Recording Secretary, who will be the staff representative, and a Corresponding Secretary, elected by and from the Council membership.

ARTICLE IV - OFFICERS -continued

- Section 2: The officers of this Council shall be elected at the January meeting each year to serve for a term of one year and until their successors shall be elected.
- Section 3: It shall be the duty of the Chairperson to preside at all meetings of the Council, maintain order, appoint all committees subject to the approval of the Council and see that the officers and committees perform their respective duties.
- Section 4: In the absence of the Chairperson, the Vice-Chairperson shall perform all duties of the Chairperson.
- Section 5: The Recording Secretary shall keep a current roll of all the members, the minutes of proceedings of this Council, and a record of matters of interest to the Council. The Recording Secretary shall be representative of the San Diego Park and Recreation Department. The Corresponding Secretary shall conduct all correspondence of this Council.

ARTICLE V

COUNCIL MEETINGS

- Section 1: There shall be stated Quarterly Meetings of the Council to be held the fourth Wednesday of January, April, July and October.
- Section 2: The order of business for the Quarterly Meetings shall be as follows:
1. Roll Call
 2. Reading of Minutes by Recording Secretary
 3. Chairperson's Report
 4. Staff Report
 5. Corresponding Secretary's Report
 6. Report of Committees
 7. Old Business
 8. New Business
 9. Time and location of next meeting
 10. Adjournment
- Section 3: All members in good standing of their certified representative shall have the privilege of representation at all meetings of this Council.
- Section 4: All meetings of this Council are open to the public.
- Section 5: Special Meetings of the Council may be called on one week's written notice by a majority of the officers at any time and shall be called by the Corresponding Secretary at the request of any six members of the Council, such notice stating the subject or subjects to be considered.
- Section 6: At all meetings of this Council the vote of a majority of its members shall constitute a quorum.

ARTICLE VI

MISCELLANEOUS

Section 1: Amendments to these Bylaws may be made at Quarterly or Special Meetings of this Council by a vote of two-thirds of the membership entitled to vote; provided that at least 30 days notice of such intention to amend be mailed by the Corresponding Secretary to all members entitled to vote; and such notice, furthermore, to contain a copy of the proposed amendments to the Bylaws; provided approval has been authorized by the San Diego Park and Recreation Department.

Section 2: All items not covered in these Bylaws and meetings of the Council shall be conducted pursuant to Robert's Rules of Order (revised).
